**Application Procedures:**

1. Applications are being accepted for **limited enrollment of Kindergarten through 8<sup>th</sup> grades and Learning Options (Alternative Ed, 10<sup>th</sup> – 12<sup>th</sup> grades), and PHASES (non-diploma 18 – 26 year old students with special needs) for the 2019-2020 school year.**
2. The buildings available for Schools of Choice students, and the number of spaces in each building, will be determined by Lake Orion Community Schools.
3. If applicants exceed spaces available, a lottery will be held as specified by State Law on **May 15, 2019**. All applicants will be notified of their enrollment status **by May 17, 2019**.
4. If your name is not drawn in the lottery for admission to Lake Orion Community Schools, we will maintain your name on a waiting list and you will be notified as additional space becomes available.
5. If accepted for attendance, every effort will be made to accommodate building preferences. However, students will be assigned based on available space. 10<sup>th</sup> – 12<sup>th</sup> graders will be placed in the district's alternative high school.
6. All applications will be screened for accurate information. This may involve contacting your current school district.
7. Your acceptance is conditional until Lake Orion Community Schools receives and reviews all school reports.
8. Lake Orion Community Schools' registration process for the selected students must be completed by **June 7, 2019**. If students are not registered by that date, Lake Orion Community Schools will assume that your application for Schools of Choice has been withdrawn and the position will be offered to the next eligible student.
9. (A) *If your child is currently eligible for special education programs and services and you reside **outside of Oakland County**, please be aware that Lake Orion Community Schools is required to secure a "Cooperative Agreement" regarding reimbursement for special education costs from your resident district before we can register your child in our school district.*  
(B) *If you reside **outside of Oakland County** and your child is found to be eligible for special education programs and services **after** admission to Lake Orion Community Schools, please be advised that the district is required to obtain a "Cooperative Agreement" regarding reimbursement for special education costs from your resident district in order for your child to remain in our school district. (MCL 388.1705c) (19)*
10. Once registered, students may remain in Lake Orion Community Schools until graduation if the student complies with all guidelines for Schools of Choice and Lake Orion Community Schools' "Code of Conduct." The only exception is cited in 9(B) above.

**Attendance:**

Students are expected to arrive and depart from school on time. Students who are excessively absent or tardy may be asked to return to their home district. It is expected that parents will pick up students on time when they are attending an after school or evening event.


**Code of Conduct:**

All student "Code of Conduct" rules, procedures, and policies will apply to all students who enter Lake Orion Community Schools under the Schools of Choice guidelines and procedures.

**Transportation:**

Parents/Guardians of Schools of Choice students are required to provide transportation to and from school.
